**Subject: Nomination of Candidates for 2018 MCC Elections**

Dear MCC member:

*Assalamu alaikum.* This is to seek nominations from you for candidates for the upcoming elections in December of this year, *inshallah*. The positions open for this year's elections are one Director in the Women category, one Director in the Young Muslims (in the age range of 18 to 35 years as of Feb 1, 2019) category, and three Directors in the General category. The nominations will be processed according to the MCC Bylaws and Nomination Procedure; you may familiarize yourself with them, and also understand the process of Nomination-by-Petition, by seeking copies from the MCC/MEC Office.

Please note that the qualifications for a Director shall include sound Islamic beliefs and practices, voting membership of MCC (in good standing) since at least December 2017, and familiarity with organizational work; the requirement for voting membership since December 2017 does not apply to the Young Muslims category. Additional qualifications to consider are printed on the back side of this letter. Please refer to bulletin boards at our Elston Avenue and Morton Grove locations for a list of current voting members and a list of those who are not eligible to be nominated. For your quick reference, the following are not eligible to be nominated for Directors because they are already on the Board or have reached their term limit(s):

You are highly encouraged to participate in the nomination and election processes by nominating the best candidates to serve the organization; make your opinion count.

## **DESIRABLE QUALITIES TO BE CONSIDERED IN NOMINATING**

### **AN INDIVIDUAL FOR AN OFFICE AT MCC**

An office in MCC is a position of trust and leadership. The following are desirable qualities that one should consider when nominating an individual for a vacancy:

1. The foremost criterion is as expressed by the Prophet (pbuh): We will nominate no one to a position of authority who affirmatively seeks it. [Ahmed]
2. The nominee has basic knowledge of Islam and displays wisdom, initiative, and tolerance in its application.
3. The nominee is a practicing Muslim (Male or Female).
4. The nominee is in agreement with the objectives and goals of the MCC and is willing to contribute to its achievements for the sake of Allah alone.
5. The nominee has demonstrated a degree of commitment by involvement and association in MCC activities.
6. The nominee has the capability of working with others in a team.
7. The nominee has the time and energy to shoulder this responsibility after taking care of family, other obligations and prior commitments.
8. A person with previous experience of working in an Islamic organization is preferable.
9. A person who regularly takes part in programs and activities of the MCC is preferable.
10. It is desirable to have the make-up of the Board representative with respect to ethnicity, sex and age.
11. A person holding an executive position in another organization having objectives and programs similar to MCC should not be given preference for an elected office in MCC.
